E-Counselling and provisional admission for Engg./Tech./Arch./Pharmacy degree courses in W.B. conducted by WBJEEB had ended on 19.07.2017. It is observed after three rounds of counselling that full or part of the provisional admission fees paid by some candidates are refundable. The various categories of refunds and the time schedule for remittances are given below -

Category	Description
<b>A</b>	Candidate paid provisional admission fees but failed to report at Reporting Centres (RCs)
<b>B</b>	Candidates paid provisional admission fees, reported at Reporting Centres but their allotment/admission was cancelled due to not fulfilling academic/domicile/reservation criteria.
<b>C</b>	Differential admission fee due to be refunded due to revised allotment.
<b>D</b>	Candidates paid provisional admission fees and later withdrawn as per the norms within the counseling period

- 1) Candidates belonging to Category **A, B, and C** are **required** to apply within 31/08/2017 (**only through speed post**) in the prescribed application form as uploaded in the Board's website. Refunds will be remitted through NEFT/RTGS expected by 15/10/2017.
- 2) Candidates belonging to Category **D** are **not required** to make any application. Refund will be remitted through NEFT/RTGS expectedly by 22/09/2017
